

Promotion Rules

ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

1. Eligibility

WCHC 2018 Ticket Promotion (the "Promotion") is open to legal residents of the fifty (50) United States, the District of Columbia, and Canada who are at least eighteen (18) years old at the time of entry. The Promotion is subject to federal, state, and local laws and regulations.

2. Sponsor

The Promotion is sponsored by West Coast Haunters Convention, located at 8703 SE 43rd, Milwaukie, Oregon 97222.

3. Agreement to Official Rules

Participation in the Promotion constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon being compliant with these Official Rules and fulfilling all other requirements set forth herein.

4. Promotion Period

The Promotion begins on December 08, 2017 at 10:00 AM PST and ends on April 08, 2018 at 5:00 pm PST (the "Promotion Period"). Entries that are submitted before or after the Promotion Period will be disqualified. Submissions will be accepted for the duration of the Promotion using the following method: Online.

5. How to Participate

Online: This method of participation will be available by visiting our website with a valid promotion code (www.hauntersconvention.com) and following the directions provided when purchasing qualifying ticket(s). You will receive regular updates each time your code is used to make qualifying purchases. The email will contain your code and current points earned.

6. Rewards

On or about April 10, 2018, the Sponsor will close the promotion and all eligible points will be tallied and rewards will be awarded. The winners will be contacted by email and their rewards can be picked up at registration, during operating hours, at the 2018 West Coast Haunters Convention at the DoubleTree at Lloyd Center April 12-15th, 2018.

7. Winner Notification

The potential winners will be notified by email. Each potential winner (parent/legal guardian if a minor in his/her state of residence) will be required to complete, electronically sign and submit a Declaration of Compliance within five (5) days of the date notice or attempted notice is sent, in order to claim his/her prize. If a potential winner cannot be contacted, or fails to submit the Declaration of Compliance within the required time period (if applicable), or prize is returned as undeliverable, potential winner forfeits prize. If the potential winner is at least 18 but still considered a minor in his/her jurisdiction of residence, Sponsor reserves the right

to award the prize in the name of his/her parent or legal guardian, who will be required to sign the Declaration of Compliance on the potential winners behalf and fulfill any other requirements imposed on winner set forth herein. Potential winners must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements.

8. Prizes

\$1,000 cash promotion (varies) - if 100 people use your code to register for the convention online (only) by April 8th 2018, you will receive a \$1,000 cash prize

\$150 cash plus 1 (one) room night at the convention hotel, and one free combo ticket if your code is used to purchase 50 tickets to the 2018 WCHC convention.

One Combo Ticket plus one room night (single or double) in the WCHC convention hotel if 25 people use your code to sign up for the 2018 WCHC by April 8th, 2018

One free Combo Ticket if 10 (ten) people use your code to sign up for the WCHC 2018 convention.

First 10 people to have their code used to reach (10 points) will receive a free mask made by Allen Hopps with Still Beast Studios.

First 10 people to have their code used to reach (10 points) will receive a free makeup kit from I (Heart) FX Makeup

9. Points

For every person that buys one or more of these qualifying tickets for the 2018 convention:

(Any) One day pass (Friday, Saturday or Sunday)

(Any) Three-day pass

Combo pass

Each ticket is worth one point. i.e. – buy one Friday, one Saturday, one Three-day and a combo pass, that is four points total. No other purchases will earn you a point, including ball and tour tickets.

Code must be used at the time of purchase. **NO EXCEPTIONS.** We will not add your code to a sale that has already processed (checkout through the site). At site purchases do not qualify.

Rewards will be given by these guidelines:

- 10-24 attendees use your code (10 points) - One 2018 Combo Ticket
- 25-49 attendees use your code (25 points) - One Combo Ticket and one Room Night during the 2018 convention.
- 50-99 attendees use your code (50 points) - One Combo Ticket, one Room Night and \$150 cash.
- 100 or more attendees use your code (100 points) - \$1,000 CASH!

One reward per code. If you get 75 people you will get the reward in the 50-99 level, not the 10-24 and the 25-49 levels.

Combining codes not allowed. Only one code per reward, point tally. No exceptions.

You cannot exchange your free ticket(s) for a refund on purchased tickets or used for future convention dates. Hotel night is for the 2018 show. No cash value if you do not stay at the hotel or stay at another hotel. Hotel offer is for the host hotel only. Hotel offer is only for a standard single or double room booked at the convention rate. Hotel offer includes the room and room tax only. No room service or guest service costs are included. If your reward is over \$600 value, you will be required to complete a tax form for the IRS. All winnings over \$600 are taxable as income.

Promotion closes on April 9th, you will be notified on or around April 10th of your reward. You may pick up your reward at registration during the 2018 show. See rules on the website for more details.

9. General Conditions

In the event that the operation, security, or administration of the Promotion is impaired in any way for any reason, including, but not limited to fraud, virus, bug, worm, unauthorized human intervention or other technical problem, or in the event the Promotion is unable to run as planned for any other reason, as determined by Sponsor in its sole discretion, the Sponsor may, in its sole discretion, either (a) suspend the Promotion to address the impairment and then resume the Promotion in a manner that best conforms to the spirit of these Official Rules or (b) terminate the Promotion and, in the event of termination, award the prize at random from among the eligible, non-suspect entries received up to the time of the impairment. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to damage the website or undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages (including attorney's fees) and any other remedies from any such person to the fullest extent permitted by law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision.

10. Release and Limitations of Liability

By participating in the Promotion, entrants agree to release and hold harmless the Sponsor, and each of their respective parents, subsidiaries, affiliates, advertising and promotion agencies, other companies associated with the Promotion, and each of their respective officers, directors, employees, shareholders, representatives, and agents (the Released Parties) from and against any claim or cause of action arising out of participation in the Promotion or receipt or use of the prize (including any travel or activity related thereto), including, but not limited to: (a) any technical errors associated with the Promotion, including lost, interrupted or unavailable Internet Service Provider (ISP), network, server, wireless service provider, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone, cellular tower or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties; (b) unauthorized human intervention in the Promotion; (c) mechanical, network, electronic, computer, human, printing or typographical errors; (d) application downloads, (e) any other errors or problems in connection with the Promotion, including, without limitation, errors that may occur in the administration of the Promotion, the announcement of the winner, the cancellation or postponement of the event and/or the flyover, if applicable, the incorrect downloading of the application, the processing of entries application downloads or in any Promotion-related materials; or (f) injury, death, losses or damages of any kind, to persons or property which may be caused, directly or indirectly, in whole or in part, from entrants participation in the Promotion or acceptance, receipt or misuse of the prize (including any travel or activity related thereto). Entrant further agrees that in any cause of action, the Released Parties liability will be limited to the cost of entering and participating in the Promotion, and in no event shall the entrant be entitled to receive attorney's fees. Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by site users, tampering, hacking, or by any equipment or programming

associated with or utilized in the Promotion. Entrant waives the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.

11. Disputes

Except where prohibited, each entrant agrees that any and all disputes, claims and causes of action arising out of, or connected with, the Promotion or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in Oregon. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, entrants rights and obligations, or the rights and obligations of the Sponsor in connection with the Promotion, shall be governed by, and construed in accordance with, the laws of Oregon, without giving effect to any choice of law or conflict of law rules, which would cause the application of the laws of any jurisdiction other than Oregon.
